ice-Chancellor, Professor Ndowa Lale, has advised the newlyinaugurated Interim Executive Committee of the Students' Union to be committed to due process and embrace the right approach to issues in its activities. Professor Lale gave the charge when he received the new student leaders in the Vice-Chancellor's Committee Room, on Thursday, March 9, 2017.

Professor Lale, congratulated the members on their selection to serve in the new positions, urging them to approach their duties with care and a sense of purpose. "Every quantum leap in life comes with challenges, responsibilities and risks. I advise you to utilise this rare opportunity given you to right the wrongs of the past by your predecessors in office. Let me assure you that I don't have any interest whatsoever in Students' Union politics or who emerges as your leaders. I only charge you to be purposeful in your leadership style and less combative in advertising your grievances on issues concerning students' welfare. Dialogue should be your watchword. neither does any member of the Management. From what I can see so far, you were carefully selected to serve your colleagues, and I am confident that you would give purposeful leadership to the generality of students who rightly look up to you for quality representation."

He decried the fact that in the last ten years, Students' Unionism had been hijacked by a vocal clique that did not care about the opinions and feelings of the generality of the students they were supposed to lead. ### Inducts 52 Medics, 14 Dental [H]Surgeons In UniP By Humphrey Ogu

the nation's fledgling health sector received yet another boost on Friday, March 10, 2017 when 52 newlyqualified Medical Doctors and 14 Dental Surgeons trained by the College of Health Sciences received their operational licences from the Medical and Dental Council of Nigeria (MDCN).

Administering the Physicians' Oath on the new Medical **Doctors and Dental Surgeons at** the 39th Induction Ceremony held at the Ebitimi Banigo Auditorium, Acting Registrar of MDCN, Dr. Tajudeen Sanusi,

charged them to abide by the Oath they swore to by rededicating themselves to saving lives.

"People often say that we in MDCN are very strict, but the truth is that medical practice involves human lives. Losing the lives of patients is inevitable, but it should not happen as a result of negligence on the part of the doctor. You must be very diligent in handling your patients. A badly trained doctor constitutes danger to the public. The best doctors are those that seek to know what they don't know. When you get to your limit, you must refer the patient to other colleagues with expertise in the area," he admonished the new entrants into the profession.

In his address, the Vice-Chancellor, Professor Ndowa Lale, who spoke through the Deputy Vice-Chancellor (Administration), Professor Anthony Ibe, said: "The main purpose of our gathering here this morning is to induct these successful graduands who have met all the stringent conditions specified by the Senate of this University for purposes of awarding them the Bachelor of Medicine/Bachelor of Surgery (MBBS) and Bachelor of Dental Surgery (BDS) degrees," expressing gratitude to MDCN for a rewarding partnership over the years.

Speaking as the Medical Elder of the Day, Deputy Governor of Rivers State, Dr. Ipalibo Harry Banigo, congratulated authorities of the University of Port Harcourt for training the doctors, charging the newlyqualified Medical Doctors and Dental Surgeons to prove the skills they acquired from the University through service to their patients.

"Suffice it to say that for you, the journey has just begun. Strive to be the best wherever you may find yourself and you must make personal sacrifices. I urge you to evoke compassion in the practice of medicine. Give yourself time to develop your skills and aspire to the zenith of your profession," she advised the inductees. She disclosed that the Rivers State Government planned to partner the **College of Health Sciences, University of Port Harcourt** Teaching Hospital and other stakeholders on how to reduce infant and maternal mortality through effective Primary Health.

On her part, Provost of the College, Professor Christie Mato, called on public-spirited individuals and corporate organisations to donate to the College and the University of Port Harcourt to deliver quality service to the public.

"We need buses to facilitate Rural Postings in K-Dere and Degema; can you give us one? Can you donate a building? We need furniture, photocopiers, desktop computers, air conditioners, laptops; can you donate consumables for dental training—artificial teeth etc. We need 100KVA generators, the list is endless. You certainly can give us something. Our account details are College of Health Sciences, U&C Account Number: 1528000040," she appealed.

In his contribution, Chief Medical Director of UPTH, Professor Aaron Ojule, noted that the resource gap for running a teaching hospital was widening by the day,

saying that time had come for everyone to join forces with government to support the hospital. "To our graduating students, I want to say that your decisions must be in the best interest of the patient. It is important for society to take care of your welfare to enable you discharge your responsibilities, but you must first make the necessary sacrifices by putting your patient first," he urged them.

Also speaking, Rivers State Branch Chairman of the Nigerian Medical Association, Dr. Datonye Alasia, commended the College for growing the number of Medical and Dental Surgeons in the country, stressing the need for the College to train many more doctors to meet the World Health Organisation's standard for doctor-patient ratio of one to 150.

In their separate Valedictory Speeches, Best Graduating Student in Dental Surgery, Dr. Vivian Ogwuegbu and her counterpart in Medicine and Surgery, Dr. Onyedikachi Onyeaso, expressed joy to God, their parents, colleagues, the College, Faculties and the University for their successful induction, promising to be good ambassadors of the University in their professional practices.

#### Amasiatu Focuses Attention On Dental Approach To Age Estimation tudent Valentine Amasiatu is a Doctoral Candidate in the Department of Human Anatomy, Faculty of Basic Medical Sciences in

the College of Health Sciences, with bias for Forensic Anatomy. Amasiatu who had earlier obtained his Bachelor and Master's degree from the same Department shares his research interest with Correspondent, ETHEL TIMI-JOHNSON.

he desire to do something different, unique and forensic in nature prompted Amasiatu to undertake a study on: Age Estimation in

Children, Adolescents and Adult Nigerians: A Dental Approach and Forensic Implications. "Data is scarce in ontodology or use of teeth to derive certain information. This research, therefore, seeks to fill that gap by providing reliable data that would be specific to Nigerians, using certain dental parameters," he said.

"Morphological, radiological and biochemical, Kim's scoring system, Dirmejian method and Williem's system are known methods that have been used in the past to estimate age, using dental parameters. This research would evaluate these different methods to determine which of them best suits the Nigerian population with a view to possibly modifying the method and making it better," he submitted. The researcher described the teeth as very important in forensic research, especially in post-mortem usage to reach critical conclusions.

Disclosing that individuals born in war-torn zones, victims of natural disasters, missing persons, persons not certain of their dates of birth or those who falsify their ages, could have their ages determined using certain dental parameters, Amasiatu noted. He expressed hope that the outcome of his research would address these issues and more and even aid medical professionals in drug administration.

"Sporting organizations, the Civil Service and others, who need to authenticate the age of athletes and their employees, would find this research useful. It would also be of help in the search for missing persons in the event

of natural disasters," he further revealed.

"Anatomically, almost every human part decays soon after death. The teeth are usually strong and the last to decay. It is possible to tell the age range of individuals by subjecting their teeth to forensic analysis. This is helpful in solving mystery cases involving missing, abandoned or dead persons," he said. Amasiatu who stated that consistent use of radiograph, exposure to x-rays through the use of orthopantomogram and the need for ethical clearance, especially for living individuals could pose challenges for the research, pointed out that the challenges would only reduce the sample size, adding that the larger the sample, the better the result.

Briefing members of Convocation at the Ebitimi Banigo Auditorium, Vice-Chancellor, Professor Ndowa Lale, said that the statutes of the University provided for a body known as Convocation made up of all graduates of the University, teachers in the University, as well as those with degrees from other recognised universities working in the University of Port Harcourt.

For the last group of persons, the Vice-Chancellor disclosed that they were required to formally apply for membership of Convocation and pay the prescribed fee before being admitted as members, adding that the Convocation played a major role in the development of each institution. Professor Lale cited the University of Lagos where alumni erected magnificent buildings for their *alma mater.* "The idea of alumni coming together is to help build the University and not to form political or economic interest blocs. The body is expected to mobilise alumni and other stakeholders for the accelerated development of the University," he told the gathering.

On a motion moved by the National President of the Alumni Association, Mr. Sampson Ngerebara, Convocation voted to cede the position of its representative on the Governing Council exclusively to the Association, with a *caveat* that the election of such a person must take place on the floor of Convocation and not at a meeting of the Association in line with the

#### enabling Act.

On another motion moved by the Executive Director of the University of Port Harcourt Foundation, Professor Henry Alapiki, and supported by the Director of the University of Port Harcourt Business School, Professor Okechuku Onuchuku, members of Convocation resolved to reschedule the election of a representation to Council, citing the scanty attendance at the gathering that included the immediate past Vice-Chancellor, Professor Joseph Ajienka and Principal Officers of the University. The meeting rose after further resolving that all alumni of the University, whether they formally registered with the Alumni Association or not, would be eligible to vote and be voted for in the rescheduled election into the Governing Council, even as the Vice-Chancellor appealed to all alumni to identify with the Association.

# V-C Commends NAFAK For Advancing Knowledge

Vice-Chancellor, Professor Ndowa Lale, has commended the National Association for the Advancement of Knowledge (NAFAK) for its multidisciplinary approach aimed at driving and advancing knowledge among disciplines.

Professor Lale made the commendation when he received the Executive members of the Association last Tuesday at the Vice-Chancellor's Committee Room, University Park. And that is why the economies of these countries are mostly knowledge-driven. It is in this respect that this Association should be taken seriously in the generation and dissemination of knowledge in which we are still lagging far behind."

He commended the Association for doing a great job in promoting knowledge, adding: "We thank you for your insight and wish your Association well and also wish that your stay in the city of Port Harcourt would be a memorable one." Speaking earlier, President of the Association, Professor John Tabotndip, praised the authorities of the University for keeping the environment clean and welcoming. "I admired your environment as I came into the Campus and it means that your staff are working hard. This is an Association that is ever seeking the advancement of knowledge, which is the preserve of a university setting. Our mandate is to develop the mind to become fully functional and productive. It is only then that this country can begin to move forward and realize its full potentials," the President said.

Professor Tabotndip said: "This country needs knowledge and if you look back, the makers of early civilisations were the ones that started driving development and any nation that does not take knowledge seriously is just wasting time and resources and is going nowhere. I immediately drafted a proposal which was tabled before the 7<sup>th</sup> Vice-Chancellor, Professor Joseph A. Ajienka. He looked at it and directed that I should go back to my colleagues in the Department of Economics and present a formal proposal," Professor Gbosi recalled. ## Kalu Assumes Office, Gbosi Bows Out As Trade Institute Director

It was after then that Dr. Nelson Olatunji introduced Professor Gbosi to Dr. Bamanga Tukur, who was President of the African Business Round-Table, necessitating the establishment of the defunct Bamanga Tukur Institute. "In attendance at the meeting were former Registrar, Mrs. Matilda Nnodim, Professor Augustus Gbosi and Professor Onyewuchi Akaranta. After our presentations, Dr. Tukur was highly impressed, and expressed readiness to partner the University on the initiative. He also promised to endow a Chair in International Trade in the Department of Economics, which was never funded as envisaged," Professor Gbosi regretted.

Presenting his report that covered 2011 to March 2017, Professor Gbosi, explained that despite the false start, the Institute laid its foundation in 2011, averring that: "2011 was spent on sending proposals to various international trade and development agencies. The administrative office of the Institute was based in my personal office in the Faculty of Social Sciences, University Park."

In 2012, the Institute produced the maiden edition of the African Journal of International Trade and Development, relocated to its

temporary office at the former Academic Office in Delta Park and participated in capacity building sessions within and outside the country. It was also in 2012 that Senate approved the Master of Science degree programme for the Institute.

"The pioneer M.Sc students commenced lectures in April, 2013 with an initial intake of 18 candidates. I attended and chaired a session of an International Conference on Global Business and Trade held in Detroit, Michigan, USA in July," Professor Gbosi disclosed, further adding that Dr. Nye Tom-Ekine was appointed Assistant Director of the Institute.

Major events that took place in 2014 included the completion of programme by the pioneer and second batch students, purchase of Toyota salon car, production of a book entitled: *Global Trade Politics and Development Finance* and signing of a joint Memorandum of Understanding with the Minister of Education and the United Nations.

In 2015, two batches of students numbering 36 graduated from the programme, while the proposal for a Doctoral degree programme in Trade and Development Finance was approved in August of that year by Senate of the University.

According to the erstwhile Director, the maiden public lecture of the Institute held on October 21, 2016 with the theme: Trade Negotiations and Development in Africa and was delivered by a Consultant with the United Nations Conference on Trade and Development (UNCTAD), Dr. Olumuyiwa Alaba.

The Institute has moved from its former office to a 12-room complex previously in Delta Park. In all, a total of 72 students had enrolled into the Master of Science degree programme with 44 already graduated, while 12 candidates enrolled into the Doctoral programme.

"One of our graduates is now working with the United Nations Conference on Trade and Development (UNCTAD), two are working with the Nigerian Export Promotion Council and another two are working with some big banks in Nigeria," Professor Gbosi said.

Taking over the leadership, the new Director, Professor Sylva Kalu, showered praises on his predecessor for laying a solid foundation for the Institute. "It is not easy to start something, so I want to thank Professor Gbosi for laying a good foundation for the Institute. I will call on him from time to time to assist with his expertise and also give us good insight on the Institute," the new Director said.

Professor Kalu promised to take the Institute to the next level by embarking on improved partnerships with local and international trade organisations, government agencies, private sector and other academic institutions. He expressed readiness to put in place proactive measures to improve enrolment in programmes run by the Institute.

y ays of reclaiming the original potentials of indigenous musical arts and resisting modernist exocentric ideologies and fashions that repress and replace original African cultural intellect and virtues, formed the main thrust of the 3" Sir Clement Nimenibo Memorial Lecture and Concert hosted by the Department of Music.

Delivering the lecture entitled: Reclaiming and Reenacting the Humanity Virtues of Musical Arts Heritage for a Sublime Posterity at the Orpheus Recital Hall of the Department, last Tuesday, Professor Meki Nzewi, noted that genuine reclamation of the African musical heritage entailed cognitive research, discernment and the advancement of art.

"Re-enactment of authoritative African Indigenous Knowledge System (IKS) is critical in culturesensed modern classroom education sites. Proactive IKS will combat the overwhelming cultural amnesia and mimic mentality besieging and bastardising modernist African life orientation," he explained. He added that cultural musical arts socialisation could purge and curtail the psychical injuries inflicted on the populace by modernity gadgets and lifestyles.

Professor Nzewi declared: "Indigenous musical arts were a divine agency functionally conceived and applied to overseeing morality canons and societal management. In the modernist age of humanity, the musical arts have become stripped of their original proactive conceptualisations as divine overseers of sublime society systems, and split into microspecialisations for vacuous entertainment business and ego-frivolities, which lack healing interactiveness and societal function." He dismissed the emergent trend as sheer entertainment that was capable of mind-diverting pursuits.

#### OUR ERROR

### Nwaichi Ends Training ( GCCE, Chemical Safety

Senior Lecturer in the Department of Biochemistry, Faculty of Science, Dr. Eucharia Nwaichi, has ended a well-attended Step-Down Training on Global Chemists Code of Ethics, Chemical Safety and Security.

Briefing participants before the commencement of the training, which held at the Centre for Gas, Refining and Petrochemicals Auditorium, NLNG Building, last Wednesday, Dr. Nwaichi, disclosed that the Global Chemists Code of Ethics (GCCE) was aimed at ensuring that chemical practitioners and allied professionals become passionate advocates of safe and secure application of chemistry for the benefit of humankind and preservation of the fragile environment for future generations.

"Chemical practitioners have a duty to promote a positive perception, public understanding and appreciation of chemistry, while practitioners should provide professional inputs and opinions to government and other decision makers regarding industrial, environmental and other issues associated with chemicals," she said.

"The GCCE has five major sections which cover

environment, research, scientific writing and publishing, including safety and security. It has key elements which border on accountability, oversight functions, exchange of information, awareness, engagement and ethics amongst others, as well as guidelines for use by the academia, industry and for export control," Dr. Nwaichi said at the opening ceremony. She further stated that policy makers and chemistry professionals could encourage ethical research practices and adopt internationally recognised standards for chemical safety and security."

Emphasising the importance of chemical safety and security, Dr. Nwaichi, pointed out that chemical storage and security would specifically support the ability of scientists to operate without restrictions to travel, collaborate or otherwise have meaningful discourse. "Daily commitment from all experts and other individuals in an institution is required for effective safety and security programme. It is important for individuals to work together to eliminate the risk of exposure to hazardous materials and conditions in the laboratory," she further told the participants.

In his address, representative of the Vice-Chancellor

and Dean of the Faculty of Science, Professor Gordon Obute, commended Dr. Nwaichi for her sustained effort at organising the training for purposes of experience-sharing, following sponsored international trainings in her area of specialisation. "This is a loud call for chemistry teachers and other professionals to practise the subject with responsibility," he said, calling on other staff, who benefit from such global exposures to emulate her example through experience-sharing workshops on their return.

## PAGE 7 CampusNetro Specialist Calls For Regular Eye Check At World Glaucoma Day

The Rivers/Bayelsa States Chapter of the Ophthalmological Society of Nigeria joined the rest of the world to mark this year's *Glaucoma Week* with a call on people to go for regular eye checks for early diagnosis of the disease that often leads to blindness.

Speaking during a free screening exercise with the theme: Beat Invisible Glaucoma, which held at the Ebitimi Banigo Auditorium from March 12 to 18, 2017, a Consultant Ophthalmologist and Glaucoma Specialist, Dr. Elizabeth Awoyesuku, revealed that the essence of the Glaucoma Week was to create more awareness about the deadly disease that could lead to blindness and to remind those already diagnosed with glaucoma about the need to continue treatment and follow up doctor's appointment.

"Glaucoma gradually damages the optic nerve in the eyes and may result in total loss of vision. It is often called the silent thief of sight because of its slow onset and progression, causing permanent loss of vision with very few or no early warning signs," Dr. Awoyesuku warned.

On the causes of glaucoma, the Specialist said that it was frequently caused by a build-up of pressure inside the eyes called Intraocular Pressure (IOP). "Normally the eye fluid circulates through the front chamber of the eyes to nourish and protect eye structures. The fluid then flows out through a drainage canal situated in the angle of the front part of the eyes. If the drainage canal becomes blocked, pressure builds up inside the eyes and damages the optic nerve, which is responsible for transmitting images to the brain. Once the optic nerve cannot regenerate, the resulting damage leads to permanent loss of vision," the Ophthalmologist disclosed.

"If a person is getting older from forty and above, he or she is likely to have the disease which could be hereditary or attributed to pressure in the eyes. Research has shown that black people are likely to be more predisposed to the disease. Glaucoma is also common in people that are hypertensive and diabetic and if a person has had an eye surgery, injuries in the eyes resulting from a slap or blow called secondary glaucoma, such a person is likely to develop the disease and if nothing is done, it could lead to blindness. If the disease is diagnosed on time, progression could be halted and it could be controlled with specialised medication for life. All glaucoma treatments are aimed at lowering eyes pressure and medical and laser therapy, including surgery," she said.



**P** or 9 years, a civil law case has been raging against the Coca Cola Bottling Company, manufacturers of *Fanta* and *Sprife*, that impacts directly on our health and lives.

The story outline: one Dr. Fijabi, had in 2007, bought about N12 million worth of *Fanta* and *Sprite* drinks from Coca Cola Ltd and exported same to the United Kingdom for commercial transaction. Once they arrived in England, the Health and Safety regulations authorities tested the products and found them to contain "poisonous levels of Benzoic Acid and Sunset additives" and were, therefore, declared "unfit for human consumption."

The whole export consignment was consequently destroyed, whereupon Dr. Fijabi sued Coca Cola for negligence, breach of duty of care to its customers, and loss of earnings.

Now comes the interesting part: The almighty Coca Cola only offered one defence in Her Majesty's Crown Court: "Mr. Fijabi did not tell us he was going to export the *Fanta* and *Sprite* to England. The products were only manufactured "FOR LOCAL CONSUMPTION." What? For local consumption?

So, the Coca Cola Bottling Company is telling us that if it knew that the *Fanta* and *Sprite* were to be exported to England, it would not have added so much poisonous acid to them! So, it is normal to serially poison the people of Nigeria for profit purposes?

That is the official courtroom statement of Coca Cola Bottling Company of Nigeria. Last Wednesday, Justice Adedayo Oyebanji of the Lagos High Court, was 'crying' when he gave judgement against Coca Cola, declaring the company as callous and grossly negligent in Nigeria. He cursed NAFDAC for failing to carry out proper laboratory checks on 'minerals' produced in Nigeria.

Cancer was listed as one of the ailments that the present Fanta

and Sprite can cause, especially if taken with Vitamin C tablets. The Judge, therefore, ordered Coca Cola to henceforth add a WRITTEN WARNING on Fanta and Sprite bottles: "This product must not be taken with Vitamin C." Once again, Oyinbo has come to our rescue!
